TECHNICAL REQUIREMENTS

Scope of Works:

- a. Protect all equipment and properties within the Licab WD specified Area of Responsibility (AOR) against loss and or damages;
- b. Ensure the security and safety of all personnel and visitors transacting business inside the specified AOR;
- c. Maintain peace and order; and
- d. Effectively enforce Rules and Regulations, Standard Operation Procedure's/Memo-Circulars/Directives with regards to security and safety matters.

Qualification of Security Guards:

- a. Must be Filipino citizen;
- b. At least a high school graduate;
- c. At least twenty one (21) years old but not more than fifty (50) years old;
- d. At least 5'4" tall for male ;
- e. Must be physically and mentally fit as indicated in neuro-psychiatric clearance from PNP and DOH-accredited institution;
- f. Of good moral character and cleared by law enforcement or police agencies or National Bureau of Investigation and has not been convicted by final judgment of a criminal offense involving moral turpitude. For former armed service personnel, must submit honorable discharge documents;
- g. Possessed licensed firearms and properly screened and cleared by the PNP for this purpose, copies of such clearances to be furnished to ESB management upon posting;
- h. Holder of Certificate of Training for Security Guard and other requirements of R.A. 5487 as amended;
- i. Holder of valid security guard's license issued by PNP-SOSIA and valid for at least six (6) months from the date of posting;
- j. Trained in handling firearms with Certificate of Training issued by training schools accredited by TESDA or PNP;
- k. In complete set of Uniform armed with required firearm with extra load of ammunitions; and
- l. Capable of assimilating written and/or oral instructions in English and Filipino and can render intelligent reports.

SECURITY AGENCIES:

- a. The Security Agency must be in business for at least three (3) years and still in operation.
- b. Must be registered with PHILGEPS.
- c. Must have a valid and current Regular License to Operate a Private Security Agency issued by the PNP-Supervisory Office for Security and Investigation Agencies (SOSIA); (Original/Certified True Copy).
- d. Member of Philippine Association of Detectives and Protection Agency Operators (PADPAO).
